Meeting Minutes:

Minutes - Kettle Moraine Riders Snowmobile Club Tuesday, March 7, 2017 Suhmer's Saloon – Eagle, WI

Meeting called to order at 7:10 p.m. by President Craig Keys.

Attendance: 19

<u>Secretary's report</u>: The February Minutes were in the newsletter. Carter Shelton motioned to accept, Karen Johnson seconded.

<u>Treasurer's report:</u>

Checking: \$8,307.19 PayPal: \$1,917.58 Total \$10,224.77

\$226.00 on account for the 50/50 raffle.

Karen handed out the financial statement to the group and briefly discussed it. Steve Shaffer motioned to accept the financial statement, Dave Dill seconded.

Craig indicated that as we had a member volunteer to do the audit report, we will go with volunteers this year. He asked if anyone would be interested in going over the audit report with the first volunteer. Carter Shelton volunteered his services.

<u>Board Member report</u>: We are now up-to-date with By-Laws and have started working on Rules and Regulations. We are hoping to have the changes to bring to the next meeting.

Old Business:

- <u>AWSC Convention</u> at Potawatomi Casino March 24-26. They are looking for donations of a raffle basket or cash. Steve Shaffer motioned to approve a \$50 gift card, Tim Arquette seconded. Motioned carried.
- <u>County Raffle Tickets</u>: Craig has a supply of tickets available. The drawing is April 12.
- <u>Chili Brat Bash</u>: Our tentative profit this year was \$4,882.45, which is about \$200.00 more than last year. The wrap-up meeting was held prior to the club meeting to go over ideas for next year. We sold 955 tickets for the main raffle. If anyone in the membership has suggestions or comments, please let any board member know.
- <u>AWSC Legislative update</u> They are trying to increase the maintenance fee from \$250 a mile to \$300 a mile to give more money to trail maintenance in general. Dan will send out an email with information on how to contact your State Representative.

New Business:

- <u>Club Dinner</u>: The dinner will be held at Brookwood. The date will be either April 22 or April 29. The membership indicated that it didn't matter to them whether the dinner was sitdown or buffet. An email will be going out to the membership to finalize the date and get a head count. Karen read the list of those who have earned their dinner. Drinks are not provided.
- <u>Earning dinner:</u> New guidelines have been created to earn the annual dinner. Dave Douglas went over the guidelines. There are a number of ways to earn a credit, and two credits are needed to earn the dinner.
- <u>Webmaster</u>: Dave asked for Chili Bash pictures. The sponsor list will also be posted on the website.
- <u>Lake Geneva SnoCross</u>: The dates are March 17-19. Snow is being trucked in as well as made.
- Brewers outing: The date is June 17th. We do not have to purchase a minimum for group sales this year. Karen asked for right field loge outfield and tickets are \$30 each. Loge infield seats are \$42 each. Karen proposed that the club pays for a bus to go or we caravan in our own vehicles and have the club pay for the parking. Karen will purchase 20 tickets and will look into a tailgate permit. Jim Kilpatrick will do the cooking.
- <u>Trailmaster</u>: Trails are closed. There is a situation in Red Brae that we'll leave until next year. There is an unhappy resident that does not want the trail near his residence. Dan will start pulling out the bigger trail items. He printed out copies of the certificates of Groomer Corp. We currently have 65 shares. Dan checked with Harold regarding the status of our brushing check. He thought it would be another month or so before we receive it. Trail

takedown will be Sunday, April 2, with a rain date of Saturday, April 8. Meet at storage shed #3 off of Hwy. E at 9:00 a.m. We'll look into early May for highway clean-up. Dave Douglas asked if anything further is going to be done to the bridge, but Dan said that he thinks because of the size of it, it's okay without rails.

- <u>Nominations</u>: The Trailmaster position will now be considered a board member which was approved by the board. Craig discussed ballots and the open positions. Treasurer, Vice President, two Board Members, and Snowmobiler of the Year are being voted on tonight.
- 50/50 Raffle: The winner of the final drawing (\$322.00) is Dan Rydeski.
- <u>Voting results</u>: Vice President: Dave Douglas; Treasurer: Vickie Kusch; Board Members: Dave Kalusche and Steve Piraino; Snowmobiler of the Year: Robin Douglas.

Motion to adjourn by Carter Shelton, seconded by Kim Zipprich. Meeting adjourned at 8:13 p.m.
